The main theme will be a discussion on the future of road transport in the EU, notably regarding the many challenges relates to the green transition of the transport sector.

On the second day we aim to meet with a representative from the **European Commission** and then the group will split to meet with our national embassies. The discussions here will focus on the current state of play in the implementation and enforcement of the Mobility Package.

On the evening a dinner will be organised on the Grand Place of Brussels.

As our associations belong to different countries with different languages, these meetings will be held in English, also to encourage international networking among the participants.
